- The Government Council shall comply with all the conditions mentioned in Rule 4(4).
- The school premises shall be subject to the condition of providing building, furniture, staff, financial facilities, etc.
- The said educational institution shall not open more departments under any circumstances without the prior permission of the Government.
- The school shall be run only in the approved medium and at the same place and no change of location shall be allowed for any reason.
- The same board to which permission has been given to run the school shall run the school at the same place and under the same name.
- This educational institution shall comply with all the vegetable orders in force and issued earlier regarding educational institutions. The Karnataka Education Act 1983 and the rules made thereunder shall be strictly followed.

- 8. This high school registration shall be permanently unaided as per Government Notification No. ED: 175: PMC: 95, Dated: 07.09.1998 and Dated. 29.12.1998.
